Dear Sir or Madam:

On behalf of Hero Licenseco, LLC ("Hero"), licensee of Station KBEH(TV), Channel 63, Oxnard, California (the "Station"), and pursuant to Section 614 of the Communications Act and Section 76.64 of the Rules and Regulations of the Federal Communications Commission, I notify you that Hero hereby elects must carry for the carriage of the Station on all of the cable systems in the Los Angeles, California DMA that Time Warner purchased from, and were formerly operated by, Adelphia Communications Corporation ("Adelphia Systems").


As you know, Station KBEH is currently carried on the remainder of your Los Angeles DMA cable systems pursuant to a retransmission consent agreement dated June 7, 2005 (as amended on July 28, 2006) and expiring on December 31, 2011, between Time Warner Cable, Inc. and Bela, LLC, Hero's corporate predecessor (hereinafter, "Agreement"). Paragraph 4 of the July 28, 2006 Amendment added language to paragraph 2 of the Agreement specifying that carriage of the Station on the former Adelphia Systems would not be subject to the terms of that Agreement. This must-carry election letter applies only to the former Adelphia Systems, and is not intended to modify the terms of the Agreement, or the manner of carriage of the Station on the remaining Time Warner systems included under the Agreement.
